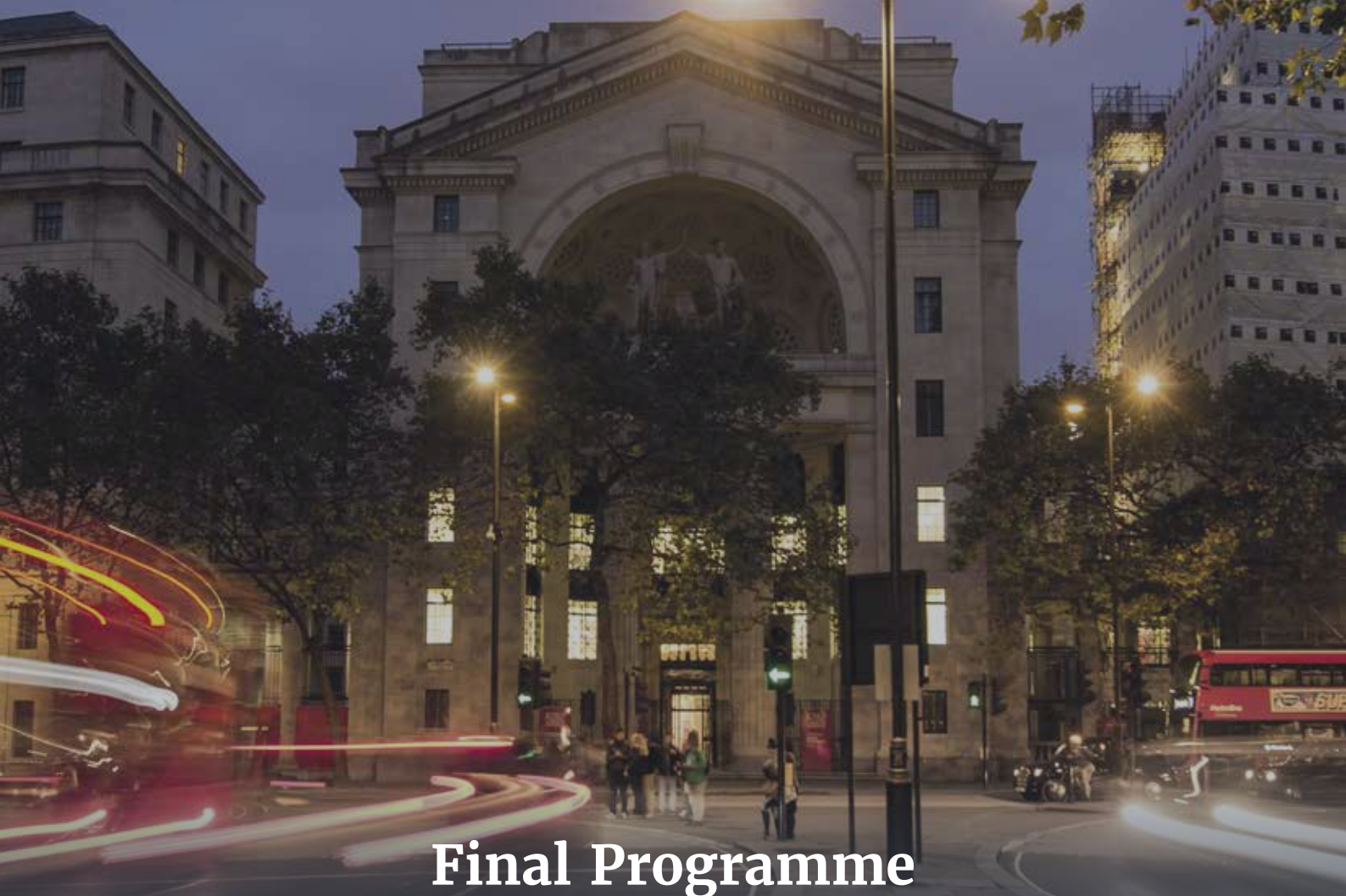

Welcome from Professor Catharine MacMillan, SLS President

London called

It gives me great pleasure to welcome you to London for the 113th annual conference of the Society of Legal Scholars. The theme for our conference this year is 'The links and connections to legal development'. Legal rules, ideas and concepts develop as a result of diverse influences, both internal and external to any legal system. Over four days speakers and delegates will explore how links and connections both within one legal system and across different legal systems work to influence the development of law. As John Donne observed, '[n]o man is an island, entire of itself'.

Our four plenary sessions address different forms of links and connections from a range of perspectives and in a variety of areas of law and history. The first plenary, *The Anatomy of Succession*, is followed by *Poetry and Judgments*; both are held on Wednesday. On Thursday our third plenary explores *Legal diffusion between West and East: There's nothing new under the sun, or is there?* On Friday our fourth and final plenary provides an historical examination with *The Travels of Treason*.

The venue for our conference is Bush House, centrally located between Aldwych and the Strand, in the heart of legal London. By a happy coincidence the venue is

integrally connected to our conference theme since Bush House was for many years the home of the BBC World Service: it was from Bush House that radio broadcasts to the world opened with the introduction 'this is London calling'. The radio links established in the twentieth century between London and the world mirror those links between legal systems in the United Kingdom with those around the world. Connections, once established, have powerful and often unpredictable consequences. Located within Bush House for our conference are social spaces which allow delegates to renew old connections and to form new ones. Bush House is also the location for the publishers' exhibitions. The Society is extremely grateful for the support of these publishers.

The end of Covid-19 restrictions allows us a full social programme. Our dinners are all in unique London venues from the rooftop of Bush House to the Great Hall at the Honourable Society of Lincoln's Inn to the House of Commons Members' Dining Room. For those who wish to explore London guided tours of Legal London and Dickens London are available. For those delegates who prefer a more spontaneous meeting with fellow scholars London offers an unrivalled choice of venues from the unique to the commonplace.

I am grateful to my many colleagues at King's College London and in the Dickson Poon School of Law for their support in planning and executing this conference. Within the Society, I would like to express my deep gratitude to the Officers and Members of the Executive Committee for their unfailing support during my year in office. I have particularly appreciated the administrative support I have received from Rosa Bladon and Sara Bladon. Our conference has continued to be organised by Mosaic Events and I would like to thank their team, particularly Sarah Byrne, for working tirelessly and efficiently – and through all the uncertainties of a Covid-19 environment – to ensure that our conference is a success.

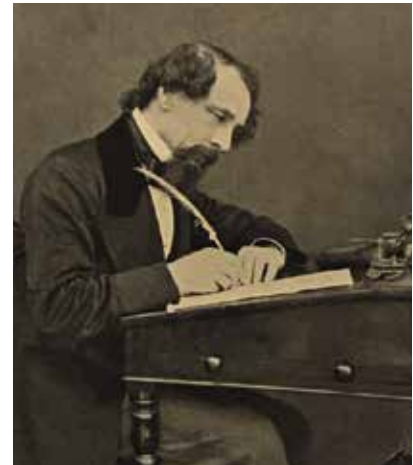

A sojourn into a lost city – an Atlantis

Dickens and London? He wrote London. You read him, it's part of you, you're part of it. Same goes for walking his London. Pip's lodgings in Great Expectations ("who enters here leaves noise behind"); the bank which employed "resurrection man" Jerry Cruncher in A Tale of Two Cities; Tulkinghorn's chambers ("where lawyers lie like maggots in nuts") in Bleak House; even the "original" Old Curiosity Shop (or is it?). Dickens immortal Sam Weller had "extensive and peculiar" knowledge of London. This walk keeps that tradition alive. Tradition and peculiar being the watchwords. 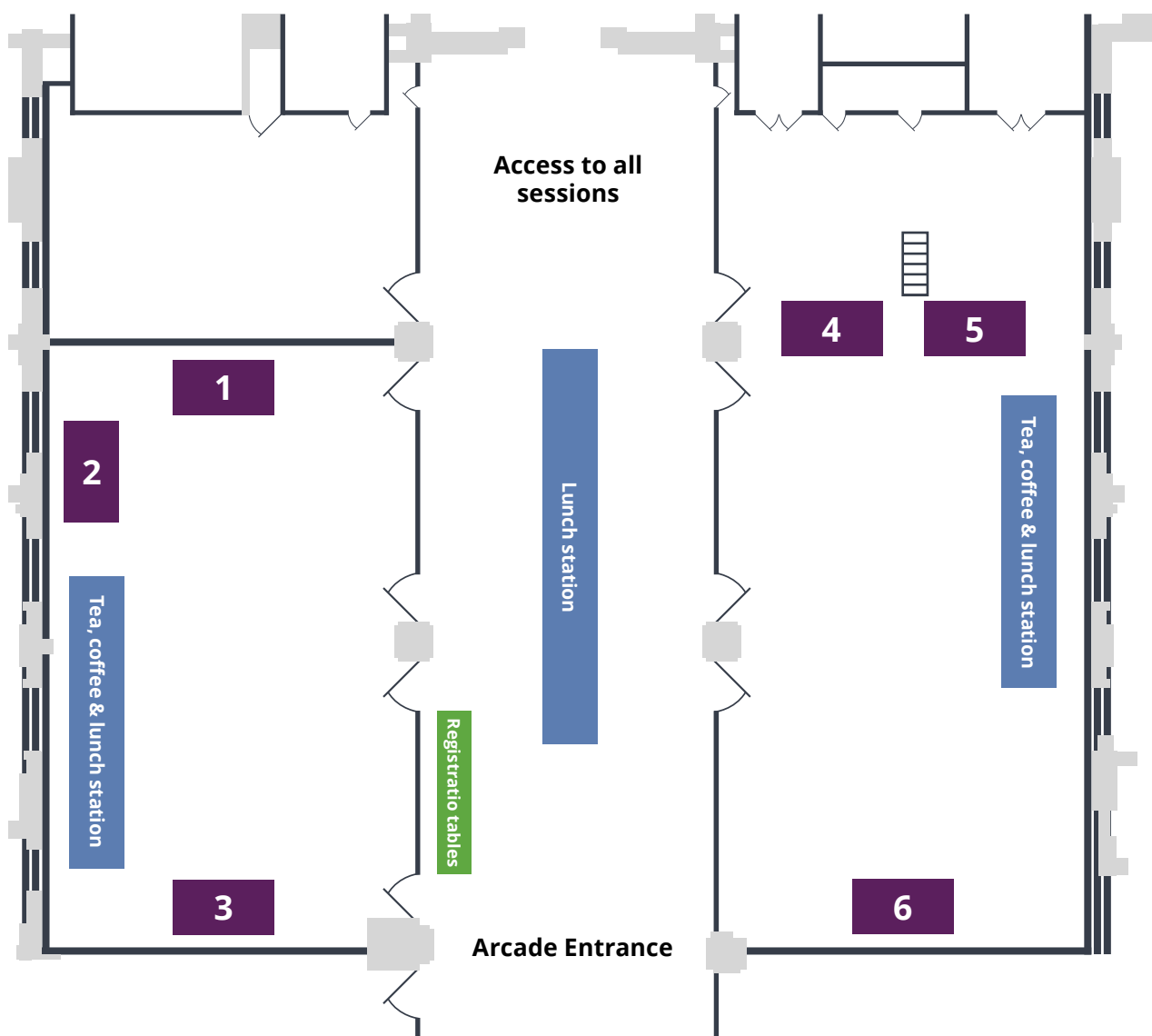

The 114th Annual Conference of the Society of Legal Scholars will be hosted by Oxford Brookes University. Oxford Brookes University has over 150 years of history, with its start as a small School of Art in borrowed teaching rooms. Conference papers relevant to any aspect of the broad conference theme

will be welcome, as well as those directed to other topics.

Headington and Oxford enjoy excellent public transport links. Regular buses from London stop outside the Brookes campus, and there are bus links from the train station too. There is no parking available at Oxford Brookes, unless needed to accommodate disability.
